

## **Health Guarantee**

To the best of our knowledge, all puppies are guaranteed to be in good health at the time of sale.

Your puppy will have been immunized at 6 - 7 weeks with the following vaccination: Canine Distemper, Adenovirus Type 2, Parainfluenza, and Parvovirus. The fact that the puppy has been immunized does not guarantee immunity. The vaccine series needs to be repeated again at 10 weeks and 14 weeks or as directed by your veterinarian.

The puppy has been wormed with Pyrantel Pamoate on a regular schedule for round and hookworms.

For this guarantee to be valid the buyer must have the puppy examined by a licensed veterinarian within 72 hours of the date of purchase. During the initial exam, should a veterinarian find a serious medical problem with the puppy the buyer must contact the seller immediately. Injury is beyond the sellers control and is not guaranteed.

Your puppy is guaranteed for one year against genetic defects that would make the puppy unsuitable as a "family pet". The buyer understands that slight genetic defects are not life threatening and therefore not covering umbilical hernia, inguinal hernia, cherry eye, undescended testicle, under bite or overbite.

Every effort is made to ensure the puppy's health and well being. The seller is not responsible for any stress or environmentally induced disorders such as, but not limited to, kennel cough, pneumonia, hypoglycemia, coccidiosis, allergies, parasites, mites, and other autoimmune disorders that are not covered in the guarantee. These conditions are all treatable and do not warrant an exchange in puppy.

If a major life threatening hereditary condition does occur, the buyer must provide to the seller a written veterinarian report stating the puppy's genetic condition and the cause of that defect or condition. This report must be submitted in writing and signed by a licensed veterinarian which is to be examined by the sellers veterinarian. A second opinion may be required by the breeder as well. If justifiable by both vets, the defective puppy will be replaced when a puppy becomes available or the purchase price will be returned at the sellers sole discretion. If sudden death should occur an autopsy must be performed and the report verified by our veterinarian to determine the cause of death. If death occurred from a congenital problem, the breeder will provide a replacement puppy of the same sex and equal value when a puppy becomes available or the purchase price will be returned at the sellers sole discretion. The seller is not responsible for any vet bills or expenses.

Our puppies and dogs have not been exposed to infectious diseases at our breeding location. This health guarantee is not valid if your puppy is exposed to an infectious disease after it leaves this location. Our health guarantee does not cover infectious diseases, as we have no control over what the puppy is exposed to after it leaves our premises. Breeder also cannot guarantee that your puppy will never develop any health problems, such things cannot be predicted. The parents are disease-free, disorder-free, and health problem-free. This means the puppies are less likely to

develop problems; however, it doesn't guarantee they will never develop a problem.

If, for any reason, during the pets lifetime an owner needs to find a new home for a dog that we have sold them, the buyer will contact the seller before offering the puppy to any person or institution. We can assist you with finding him/her a new home — no refunds. Do not sell or give away the dog without the permission of the seller.

If the seller decides that the buyer is not suited for a Pembroke Welsh Corgi puppy for any reason the seller has the right to cancel the sale before the delivery of the puppy. The buyers deposit will be refunded upon cancellation.

If the need arises, shipping will be considered and is based upon the sellers decision. All shipping costs are the buyers responsibility.

AKC registration forms and health records will be received by the buyer within 45 days of purchase.

The puppies are sold as pet quality puppies. The seller does not guarantee a puppy as show quality or to have the ability to sire or whelp puppies.

A \$100 deposit will hold the puppy. The deposit will be applied to the purchase price of the puppy. All deposits are non-refundable.

I, the buyer, have read this contract, understand fully, and agree to abide by these conditions in order to keep this guarantee in full effect.
